Neonatal deaths from respiratory distress secondary to goiter have been reported. Iodides have been known to cause drug-induced fevers, which are usually of short duration. Lanthanons can cause delayed blood clotting leading to hemorrhages. Exposure may also lead to sensitivity to heat, itching, increased awareness of odor and taste, and liver damage.

Signs & Symptoms: Burning sensation, cough, wheezing, laryngitis, shortness of breath, headache, nausea, vomiting, drowsiness, ataxia, irregular breathing.
